

**PURPOSE**

The purpose of the Christine Bohr Anderson Scholarship is to assist North Carolina Lutheran women who wish to pursue a seminary education. (Note: This scholarship is not restricted by age or ethnicity of recipient.)

**FUNDS**

Scholarships of \$1,000.00 each are available.

**REQUIREMENTS**

- a. Full-time seminary student
- b. Resident of North Carolina
- c. Completed CBA Scholarship application form, including all required material, submitted to the Scholarship Chair by April 1 deadline.

**MATERIALS TO BE SUBMITTED**

- a. Completed application form (including financial information requested on form)
- b. Recent photograph of applicant
- c. Transcript
- d. Two letters of reference, one of which must be from applicant’s advisor
- e. Paragraph explaining how applicant will serve the church when seminary studies are completed. Please elaborate how applicant will assist women to reach their full potential. All or part of this may be used to publicize the CBA Scholarship.
- f. Address where applicant can be reached after May 1.

**AGREEMENT**

- a. Recipient can receive another scholarship for the time covered by this scholarship; however, should a *full* scholarship be received, the recipient

must notify the Scholarship Chair and relinquish this scholarship.

- b. If the recipient withdraws from the school during the summer, the recipient must notify the Scholarship Chair and relinquish this scholarship.
- c. If the recipient withdraws during the summer, another recipient may be selected.
- d. An applicant who has applied previously may reapply even if she is a past recipient.
